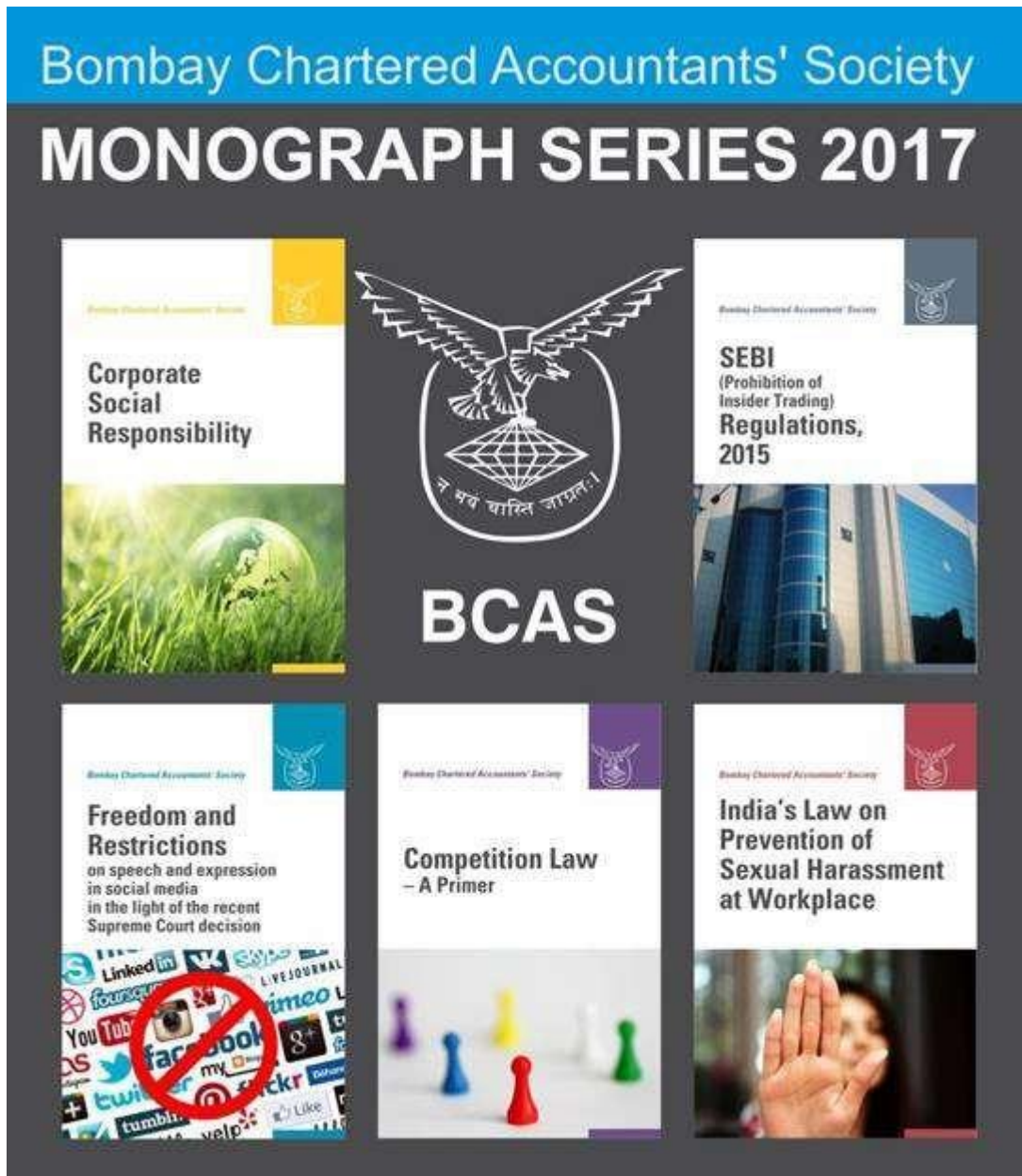

Also the provisions of Corporate Social Responsibility have come in to force to remove Inequalities amongst various sections of the society. To curb the practice of insider the trading SEBI has been tightening the relevant norms through the law relating to Prohibition of Insider Trading. Fair competition is essential for development of a healthy market and also to save the economy from the evils of monopoly. The Competition Law replaced MRTP Act to <i>inter alia</i> regulate and restrict anti-competitive agreements, abuse of dominant position and combinations (i.e., mergers, acquisitions, takeovers, etc.). In India, women have been entering formal labour workforce in an unprecedented numbers and are extremely valuable resources.
