1. Regular August ITF RRC is moved to April and hence there would be no ITF RRC in August 2023.
2. The Leela, Gandhinagar is about 22 kms from Ahmedabad Airport and estimated travel time will be around 40 minutes. Regular taxis are available from the airport to reach the Hotel.
