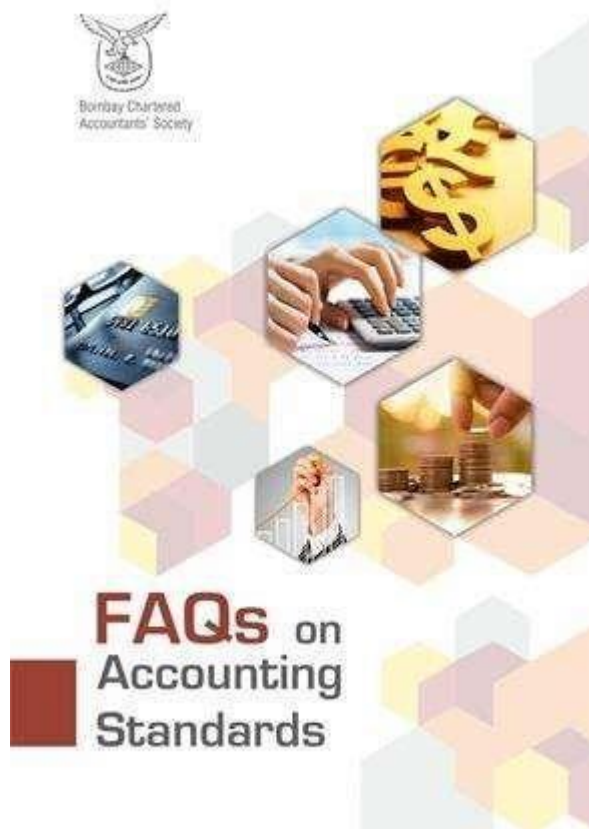

Features:	<p>For every company, preparation of financial statements is an important annual exercise. Section 133 of the Companies Act, 2013 requires companies to prepare these financial statements by following Accounting Standards (AS) as notified from time-to-time.</p> <p>Companies which are not listed and which do not meet the thresholds for adopting IND AS have to continue to follow the notified AS as amended from time-to-time. These AS are thus to be followed for a vast majority of companies, including private limited and section 25 / section 8 companies.</p> <p>To make detailed guidance available at one place, BCAS has Published a book on FAQs on Accounting Standards which would ultimately result in the appropriate preparation of financial statements and avoid compliance related notices form MCA etc.</p>
