Features:	<p>“Model Tax Convention on Income and on Capital” (Condensed Version) was released by OECD on 21st November 2017. The existing OECD Model Tax Convention has been revised in the backdrop of the various recommendations of the Base Erosion and Profit Shifting Action Plans (BEPS) wherein several articles have been revised. BCAS has the permission to publish this book under arrangement with OECD.</p> <p>The main purpose of the OECD Model Tax Convention on Income and on Capital is to provide a means of settling on a uniform basis the most common problems that arise in the field of International Juridical Double Taxation. The revised version contains periodic and more timely updates and amendments since 1977 by integrating many of the recommendations made in the earlier reports.</p> <p>Since the publication of the first ambulatory version in 1992, the Model Convention has been updated many times the last being in 2017 which included a large no of changes resulting from the OECD/G20 Base Erosion and Profit Shifting (BEPS) project and in particular from the final reports on Action 2, 6, 7 and 14 produced as part of that project. The publication contains commentary on the articles of Model Tax Convention covering the Scope, Definitions, Taxation of Income, Taxation of Capital, Methods for elimination</p>
