Sub: Suggestions on certain provisions on law and procedure related to the Registrations under the GST Act.

We understand that the Government is in the process of taking a review of various legal issues in GST with the objective of clearing the air on certain issues and bringing more clarity and certainty in the law. We have endeavored to contribute to the said process by making the following two brief representations on the various legal and procedural issues on the provisions relating to GST registration in the GST law and rules which are relevant from every taxpayer's point of view.

- a) The representation no. BCAS/IDTC/REP-01/21-22 dealing with legal issues and
- b) The representation no. BCAS/IDTC/REP-02/21-22 dealing with the procedural issues

We hope this will get due consideration and suitable amendments will be carried out in law to give effect thereto. Our team is also in the process of making representation on certain other important topics and the same will be forwarded to you at the earliest.
