1. The Course will begin on Thursday 06th June, 2024. Sessions will commence from 4:30 p.m. on Thursday, 06th June, 2024 and end by 11:30 a.m. on Sunday, 09th June, 2024.

### 2. For residential participants:

- (a) The Enrolment Fees is inclusive of lodging, boarding, course material and Rs. 50/-being contribution towards BCAS Foundation for members enrolling on a Residential basis.
- (b) Check-in time at the hotel is from 2 pm onwards on Thursday, 06th June 2024
- (c) The Course will commence with lunch on 06th June 2024, and will conclude on Sunday 09thJune 2024 after lunch.
- (d) All participants will be accommodated in earmarked rooms on twin sharing basis. The participants are requested, therefore, to <u>indicate in the enrolment form your preference of room partner</u>, if any. The Society has also provided an option of single occupancy. Interested participants may choose the said option.
- (e) Participant's are also requested to indicate their food preference in the enrolment form
- 3. BCAS Members having registered address & Non- Members (CA's & other Professionals) having a residential address in Vishakhapatnam can join as non-resident participants. The fees charged include course material, dinner on 06th June 2024 and lunches on 07th June to 09th June 2024 and Rs. 50/- as contribution to the BCAS Foundation.   - (e) Subject to Editorial review, the said article would be published in the paper book

- 7. <u>Cancellation</u>: Cancellation of enrolment will be permitted up to 30th April 2024 against a cancellation fee of Rs. 1000 + GST and the balance will be refunded back to the account of the participant. No cancellations will be permitted thereafter.
