# A 75 Hours Long Duration Study Course on 75th Anniversary of BCAS 14th March, 2024 to 7th June 2024 (Virtual Mode) Course Segments: • Assurance Standards • Accounting Standards • Ind As

Dear Members,

BCAS has always been pioneer in equipping its members in particular and other stakeholders at large with the knowledge in the arena of Accounting Standards, Ind AS and Standards on Auditing.

The adoption of Ind AS in India for listed and other large entities, since 2015, has catapulted Indian corporate sector to the centre stage of high quality and transparent financial reporting. The experience of implementing Ind AS by listed and other large companies in India has been quite challenging. In the same manner, the MCA has notified revised and updated Accounting Standards vide Accounting Standards Rules, 2021.

Besides the existing Accounting Standards notified by the Ministry of Corporate Affairs, recently the ICAI has also recommended Accounting Standards and format of the financial statements for non-corporate entities.

Professionals today are witness to plethora of NFRA orders and advisories issued based on the reviews conducted by them and have come down heavily on Audit firms for non-compliances with the Standards on Auditing. This development has brought the needed focus on the often-neglected Standards on Auditing and it has gained the well-deserved attention. Auditing being the monopoly for Chartered Accountants.

We at the Accounting & Auditing Committee thought it relevant and timely to come up with this unique idea of a long duration course in virtual mode of 75 hours of education. Spanning more than 12 weeks to be conducted online on Fridays (except for inaugural session on Thursday) and Saturdays, 3 hours on each day totalling to 75 hours.

With the main objective of dwelling deep into the Subjects affecting the Audit fraternity and to provide platform to the Members in Industry and Practice to come together and get the opportunity to get deep insights into the practical challenges which crops up while implementing the complicated standards not to forget the frequent revisions due to ever changing dynamic business requirements.

The Study Course has been planned to address the practical challenges and also share experiences of experts in dealing and addressing such challenges. Professionals involved in audit of entities applying Ind AS, IGAAP financial statements as well as Companies who prepare Ind AS financial statements or in the process of implementation of Ind AS would find the Study Course very useful to gain this knowledge and address their issues.
