## **Webinar on Filing of Income Tax Returns for AY 2024-25**

The Central Board of Direct Taxes (CBDT) notified the Income-tax Returns (ITR) forms for Assessment Year 2024-25 well in advance and even the online utilities for the ITR forms were released in the months of April and May 2024.

Since filing of an accurate and complete return of income is the first step in the direction of all future proceedings, professionals need to be vigilant towards the amendments to the Act and also the updated disclosure requirements in the return of income. Utmost care needs to be taken while filling up each field in the ITR form. A small and innocuous mistake could cost the tax payer heavily in terms of tax and interest. Therefore, it is imperative that tax payers, as well as tax professionals, are fully aware of the minutest details to be filled in.

Also, as we move towards minimum government, maximum governance, the duty cast on professionals will continue to increase manifold. In the recent past, the Government has brought in many changes, the latest being faceless assessments.
