## XIIIth Residential Study Course on Ind AS

The adoption of Ind AS in India for listed and other large entities, since 2015, has catapulted Indian corporate sector to the centre stage of high quality and transparent financial reporting. The experience of implementing Ind AS by listed and other large companies in India has been quite challenging.

With the main objective of dwelling deep into the Ind AS subject and to provide platform to the Members in Industry and Practice to come together and get the opportunity to get deep insights into the practical challenges which crops up while implementing the complicated standards, BCAS had started the subject specific Residential Study Course (RSC) for achieving the stated objective. The event became very popular instantly and now has become one of the most sought after flagship event and Members always eagerly await the program dates. This residential course is now into its 13th year and Accounting and Auditing Committee is pleased to announce the details of the RSC for this year.

The XIIIth BCAS Ind AS Residential Study Course has been planned to address the practical challenges and also share experiences of experts in dealing and addressing such challenges. Professionals involved in audit of Ind AS financial statements as well as companies who prepare Ind AS financial statements or in the process of implementation of Ind AS would find the RSC very useful to gain this knowledge and address their issues. The RSC follows a unique format of extensive group discussions on Case Studies based papers and presentation papers on subjects of topical interest. **This year we have kept 3 papers for Group Discussion covering very wide range of burning issues we all face, 1 paper for presentation followed by Panel discussions by eminent panellists touching upon important areas. The RSC would be for 2 nights 3 days in Physical mode (and not in hybrid mode).** The residential course offers an excellent opportunity to interact with all the speakers and participants through informal chats and networking sessions.
