1. The Sheraton Grand Palace Indore, is about 25 kms from Indore Airport and 13 Kms from Indore Railway Station and estimated travel time will be around 60 minutes and 35 minutes respectively. Regular taxis (including Ola and Uber) are available from the airport and Railway station to reach the Hotel. Participants are required to make their own arrangements to reach the Hotel.
