20th Residential Study Course on GST

The Indirect Taxation Committee of BCAS is pleased to announce the 20th Residential Study Course (RSC) on GST in the largest metro city of South of India, Chennai. The RSC shall be held between Thursday 25th June 2026 to Sunday 28th June 2026.

As each year, your society would present to you a different perspective for GST practice including development for the upcoming Tribunal and refining the discussions on the substantive as well as procedural aspects of law. The format comprises of:

- 1 Group Discussion Paper on substantive and procedural issues in GST;
- 1 Panel Discussion combined with a Group Discussion on a practical and live issues which are primarily based on the interpretation of statutes;
- 1 Presentation papers for utility of Jurisprudence of allied laws with GST
- Delegates Zone will have 2 Modules - T20 Sessions on live use cases of AI and Finals of Moot GST Appellate Tribunal.

The 20th RSC will take place at The Grand Chola by ITC, Chennai. We as BCAS will be holding a residential study course in GST for the first time in the city of Chennai. Hotel ITC Grand Chola [<https://www.itchotels.com/in/en/itchotels/hotels/itcgrandchola-chennai>] located on Anna Salai, Guindy in Chennai, is a 5-star luxury hotel opened in 2012, renowned for its Dravidian-inspired architecture of the Chola Dynasty, featuring intricate stone carvings. It holds status as one of India's largest hotels. 1. The above course enrolment fees are without the leisure. A separate link for course fees inclusive of leisure trip with additional Rs. 2000 + GST will be provided. Interested participants may select the same if they desire to come for leisure trip on Sunday.
2. Course Duration
 - a. The Course will begin on Thursday 25th June, 2026 with lunch for Residential participants
 - b. First technical session will commence from 03:15 p.m. on Thursday, 25th June, 2026
 - c. Last technical session will end by 08:30 p.m. on Saturday, 27th June, 2026 followed by dinner.
 - d. Course shall end with breakfast on Sunday, 28th June, 2026
 - e. Leisure is also organised post breakfast on Sunday, 28th June 2026. BCAS has organised a leisure trip at Mamallapuram (Mahabalipuram). Transportation and lunch are included in the charges for the leisure trip. The Bus shall drop the participants joining for leisure at Chennai International Airport around 4:30 PM.
3. For Residential Participants:
 - a. The Enrolment Fees is inclusive of lodging, boarding, course material and Rs. 50/- being contribution towards BCAS Foundation for members enrolling on a Residential basis.
 - b. Check-in time at the hotel is from 2:00 pm onwards on Thursday, 25th June 2026.
 - c. Check-out time at the hotel is 9:30 am on Sunday, 28th June 2026.

- d. The Course fee includes all meals from lunch of 25th June 2026 till the breakfast of Sunday 28th June 2026.
 - e. Lunch for the residential participants for the inaugural day would be between 12:30 PM to 02:45 PM.
 - f. All participants will be accommodated in earmarked rooms on twin sharing basis. The participants are requested, therefore, to indicate in the enrolment form your preference of room partner, if any. The Society has also provided an option of single occupancy. Interested participants may choose the said option.
4. For Non Residential Participants
- a. BCAS Members having registered addresses & Non- Members (CA's & other Professionals) having a residential address in Greater Chennai Metropolitan Area can join as non-resident participants.
 - b. The fees charged include course material, lunch on 26th June & 27th June and Dinner for 25th June to 27th June 2026, and; Rs. 50/- as contribution to the BCAS Foundation.
 - c. For non-residential participants lunch of 25th June 2026 is not included in the RSC fees.
5. Registration shall be restricted to the first 275 enrolments. Participants are requested to enrol early to obtain confirmed participation and also avail the discounts on the fees.
6. Delegates Participation:
- a. Any participant willing to opt as a Group Leader for any of the 2 Group Discussion Papers are requested to mark their preference in the Enrolment form while registering online only.
 - b. Delegates intending to showcase their Practical Use Cases in AI may also express their interest for the T20 Sessions.
 - c. Delegates intending to participate in the moot GSTAT, will have to follow the separate GSTAT Moot Competition announcement organised by our committee.
7. Refunds & Substitution:
- a. Once enrolled requests for Refunds will not be entertained.
 - b. Under unforeseen conditions, the registration may cancelled with a fee of Rs. 1200 + 18% GST **only upto** 15th May 2026.
 - c. No substitution will be allowed.
8. Participants are requested to fill up all the columns in the Enrolment Form as it will help the Society in planning the affairs of RSC. Participants are also required to attach Driving License / Voter's Id Card / Passport / Aadhar Card as it will be required at the Hotel. Link for uploading the said data will be provided in the RSC specific WhatsApp group before the event.
