Seminar on TDS & TCS

What It Is, What Changes & How to Stay Compliance-Ready

Dear Members,

Tax Deduction at Source (TDS) and Tax Collection at Source (TCS) continue to remain among the most significant compliance areas under the Income-tax law. With frequent amendments, new forms, evolving reporting requirements and increasing scrutiny from the tax authorities, professionals and businesses must remain updated and compliance ready.

To help professionals understand the current provisions, upcoming changes and practical compliance aspects, Bombay Chartered Accountants' Society (BCAS) jointly with Goa Chamber of Commerce & Industry (GCCCI) is organizing a full day seminar on TDS & TCS at the Surendrababu Timblo Convention Hall, GCCCI, Panaji, Goa. The programme will be conducted in **hybrid mode**, with BCAS members / non-members also participating virtually through the Zoom platform.

The seminar will cover an overview of the provisions relating to TDS and TCS under the present Income-tax Act as well as under the new Income tax Act, 2025 along with a discussion on the Draft Income-tax Rules, 2026 and the prescribed forms. The sessions will also focus on the new TDS forms applicable for Domestic, Salary and Non-Resident transactions for FY 2026–27. To provide practical insights, the speakers will discuss case studies relating to Domestic (including remuneration to partners, rent, purchase of goods etc.) and Salary TDS, along with addressing practical issues faced in withholding tax compliance, particularly in relation to foreign remittances and certifications.

The event will provide practical insights, case studies and discussion on key issues faced in withholding tax compliance including developments under the evolving income-tax framework.

This seminar will be useful for Chief Financial Officers, Finance Managers and Accounts Executives, as well as Chartered Accountants, Cost Accountants and tax professionals involved in tax compliance and advisory. It will also benefit aspiring professionals and students who wish to build a strong practical understanding of TDS and TCS compliance.
